# 14.6 Strawberry Fields / 106 agreement

PE wrote to the chief planning officer to question the validity of the 106 agreement and challenging the payment for an increased bus service which is not required. The response from CPO stated that -Yes, the agreement could be challenged and handled by LCC and the developer with no need to refer back to the Govt Planning Inspectorate.

- It is not for us to challenge but the developer. (which has now changed of course)

#### 14.7 Active Travel

KG participated in an on line session with other local areas and Local Care Partnership representatives. The Local Care Partnership is a forum where the local GP practices, local voluntary sector health workers, public agencies and councillor reps come together to try and coordinate activity to tackle public health issues. They are carrying out an active travel exercise locally to identify what are the issues/obstacles/aspirations for local active travel with an expectation that this should be based on the idea of "20 minute neighbourhoods" in part to address obesity issues, but also after Covid, isolation issues too. What will get us out of cars and on foot /cycles? KG asked for Carlton to be involved in the consultation so the Community views could be captured. Some of the points link in to our survey results.




## 14.8.2 Charity application & alternatives


