	Two emails have been sent to the Chief Planning Officer at LCC, one to the Chief Exec himself, a further two to the Case Officer for the Strawberry Fields development related to the 106 agreement. Subsequent to the meeting, PE received an email from Planning & Sustainable Development representative responding on behalf of the Chief Exec. He advises that internal meetings have already taken place and 'further engagement with the West Yorkshire Combined Authority (WYCA) is currently ongoing. '. No timescale was given for a response, merely reiteration of the legalities surrounding \$106 agreements. Response awaited.	Noted Noted
	Demolitions etc The demolition of the barn at the front of the Oldroyds' took place in January. Concern raised re presence of asbestos in the panels. Confirmation received that the HSE had attended site and they concluded that published guidance for the handling and removal of this type of asbestos had not been followed and the contractors were indeed unaware of The Control of Asbestos Regulations. There was no risk to the public at the time of the visit as the asbestos was in a locked container. LCC Enforcement officer did not pursue the reported incident to the best of our knowledge.
