8.4 Policy Intentions Document

8.4.1 . Draft document feedback from LCC

Abbie Miladinovic provided feedback on behalf of LCC on the Policy Intentions document. PE circulated the email on 25th August. Highlights:

- We would recommend that the group thinks bigger in terms of the options available overall what is the plan seeking to deliver?
- Recommend that policies focus on areas where the NP can add more detail/be more specific than the Core Strategy policies
- Always worth bearing in mind how the policy will be used by the decision maker (e.g. the planning officer writing a report on a planning application) and being as specific as possible, worthwhile considering:

- The document would benefit from having a lighter intro (overview of the work done so far) and something at the end about next steps (e.g. informal consultation before the preparation of a pre-submission draft plan)
- A key thing to think about in a revised draft would be how to tell more of a story why does the emerging plan for Carlton look the way it does? How will the policies help to deliver the vision, etc.
