10.3.3 Feedback A Miladinovic from LCC on PID Abbie has sent Peter with follow up






Speed Cameras. PE wrote as actioned to SG. Stewart confirmed with LCC Asst Traffic Engineer the cost of a VASID (vehicle activated speed indicator display) is around the £3,500 per sign. Due to the costs, SG advises need to manage expectations. Why can't CIL money from Strawberry Fields be used instead of it going on the junction Sharp lane/Copley/Wakefield Rd as Highways wish to do although outside the neighbourhood area??? 10.7 Neighbourhood Forum Re designation


