	Peter had circulated (16/3) the reply he received from Mr Johnson and this answered a number of	
	questions both in terms of definition of the terms within the report and further clarity on the	
	question of greenspaces to be included in the context of the Spaces already contained within the	
	Outer South Site Allocation Plan (which includes Carlton, Rothwell and O and W.	
	The key aspects of this related to the definition of "Local and Community Value". This is apparently	
	up to the Forum and Community "to assess what value this has to your community".	
	This was slightly stating the obvious and the question was only asked to understand the definition	

in the context of the other criteria related to the sites such as "Recreational Value", "Historical Value" and "Landscape Value". Seemed like it is a sort of catch-all description. In any event Mr Johnson gave a number of examples used by other Forums. The other issue related to including greenspaces in the Neighbourhood Plan when those spaces already existed in the Leeds Site Allocations Plan. Mr Tomas said: Policy G6 of the Leeds Core Strategy (2019) states that: "Green space (including open space and pedestrian corridors in the City Centre) will be protected from development unless one of the following criteria is met: 1. There is an adequate supply of accessible green space/open space within the analysis area and the development site offers no potential for use as an alternative deficient open space type, as illustrated in the Leeds Open Space, Sport and Recreation Assessment, or, The green space/open space is replaced by an area of at least equal size, accessibility and quality in the same locality; or Where supported by evidence and in the delivery of wider planning benefits, redevelopment proposals demonstrate a clear relationship to improvements of existing green space quality in the same locality." Designating local green space is a tool to provide special protection against development for green areas of particular important to your community. Once designated, local green spaces will be subject to the same strong development restrictions as green belt, and new development is ruled out other than in very special circumstances. In the light of this it was agreed that we would include all of the Carlton SAP Greenspace sites within the greenspace section of the Neighbourhood Plan 32.5 Public Engagement Initiatives 32.5a Smart Survey through yourvoice.leeds.gov.uk and further use of FB PE Peter had heard from Jan Cleverly with a link to a questionnaire for him to check. 	PG advised the Say no campaign is looking at Crowd Funding in the event a legal appeal is called by the developer as happened with Strawberry Fields.	
	KG has contacted the Campaign for Rural England body and awaits a response.	
	There are other applications for similar developments in Bramham although none ar sited as close to residential properties as Westfield Road.
